Amy Jenema: Tax Tribunal, Antrim County Contract.

Jenema discussed the settlement proposal for Jordan Development, LLC leases and recommended the settlement. Synopsis given on County Contract for computer services.

Motion to approve the Jordan Development settlement by Atkinson / Pharo. Motion carried.

Mark Anderson: Boat House Storage: Amendment 2016-07 Rezoning from Ag to Light Manufacturing. Weinzapfel gave an overview of the request. The planning commission recommended approval based on a majority vote. The concern is what is also approved in a light manufacturing zone. The county recommended approval because it is not incompatible with their master plan.

Mark Anderson gave a presentation regarding the request.

Peter Dornan, the attorney for Mark Anderson also commented on the request.

Bargy asked Anderson if this change was in effect, when he bought the property. Yes. It was. But when you did away with the PUD, we became non-conforming and now we can't proceed with requesting any changes to our property.

Board discussed the issue with members giving their opinions on the matter. Derman was asked, if the change was to be approved, would it be considered spot zoning. Derman said this property is a very unique situation. I would doubt that this could be considered spot zoning. Board members agreed that changing to light manufacturing, the planning commission may impose conditions on any special use application.

Motion to approve Amendment 2016-07 by Pharo. Seconded by Cole. Roll Call: Pharo – yes; Cole – yes; Atkinson – yes; Bargy – yes.

Motion carried, 4-0.
